The Government of the Democratic Socialist Republic of Sri Lanka has received Grant Aid of eight billion Japanese Yen (¥8,000,000,000) from the Government of Japan for the purchase of products and services necessary for the execution of the Program for Efforts to cope with the Damages caused by the Great Earthquake off the Coast of Sumatra, the Republic of Indonesia, and by the Indian Ocean Tsunami Disaster (hereinafter referred to as "the Programme") by the Democratic Socialist Republic of Sri Lanka.

Prequalification Documents are available at the following office of Japan International Cooperation System (JICS) from **July 6 to 8, 2005** from 10:00 to 12:00 and from 14:00 to 16:00

The application forms shall be submitted to the said office by 17:00 on **July 15, 2005**.

The applicants, however, shall be required to meet with the following conditions :

- 1 To be Sri Lankan construction companies of **M1, M2 and M3** ranking by Institute for Construction Training And Development (ICTAD), or Japanese general construction companies, which are controlled by Japanese nationals and **are equivalent to M1 ranking by ICTAD**.
- 2 To be in sound financial conditions.
- 3 To have at least **three (3) experiences** of the completed general construction works with contract price of not less than **One million US dollars (US\$1,000,000)** each, or have experiences of the completed general construction works of which the total contract price shall not be less than **Ten million US dollars (US\$10,000,000)**, either domestic or overseas, during the last ten (10) years, regardless of prime contracting or subcontracting.
- 4 To have at least **three (3) experiences** of the completed construction works for similar new construction of school building, either domestic or overseas, during the last ten (10) years, regardless of prime contracting or subcontracting.
1. 5 To have not less **than ten (10) engineers** who have been licensed in Sri Lanka or Japan.
