Accordingly, the Ministry of Economy and Finance of the Government of the Republic of Korea, in partnership with the Asian Development Bank (ADB), has invited applications from eligible government officials of ADB's developing member countries (DMCs) for the scholarship program mentioned above.

The objective of the program is to strengthen the institutional capacity of governments in developing countries by equipping officials with advanced knowledge and skills and applying their expertise to drive national development and policy reforms. The program provides the participants with the opportunity to pursue Master's degree programs (International Development Major). The program duration is 16 months from 01st of September 2025 to 31st December 2026.

Therefore, well-qualified and committed individuals who can gain broader knowledge and benefits from this program, and effectively utilize them for the country's development, may be nominated for the program. We kindly request that you adhere to the existing **budget circulars and TA circulars** when considering nominations.

The following points are highlighted for your kind attention;

- Applicants must submit their applications through email on or before the deadline of 14th April 2025. Only the final selected candidates must submit the original application documents by mail to the office of Graduate School of International Studies (GSIS), Seoul National University.
- Applicants who are selected for the Scholarship must submit a copy of the completed application form together with letter of Ministry approval and the "ERD form" once they are selected.
