<b>Course Synopsis</b>	Training Program on “Diagnosis of Pests, Pest Risk Analysis, Pest Surveillance and Phytosanitary Treatments for safe trade” will impart skills in detection and diagnosis of pests of quarantine significance by employing appropriate methods, Pest Risk Analysis and hands-on skills on various Phytosanitary measures specially fumigation and heat treatment.
<b>Course Duration</b>	two weeks
<b>Justification/ Rationale</b>	<p><b>NIPHM</b> is a National level premier institute under the administrative control of the Department of Agriculture &amp; Cooperation, Ministry of Agriculture &amp; Farmer’s welfare, Government of India. NIPHM is promoting environmentally sustainable Plant Health Management practices in diverse and changing agro-climatic conditions, Plant Biosecurity and SPS Measures and Pesticide Management through capacity building programmes, besides providing inputs for policy formulation on Plant Health Management, Plant Biosecurity, Invasive Alien Species, market access, Pesticide Management etc. at state and national level.
