We wish to inform you that the Singapore Cooperation Programme (SCP) has invited nominations from the eligible Government officials for the above programme. The programme details are enclosed herewith for your reference.

We would like to bring to your kind attention that the nominations need to be in accordance with the information given under "application information" in the programme details.

Please be informed that according to the Guidelines of this Programme, the airfare needs to be borne by the nominating Government. As per the directions of the National Budget Circular no.BD/CBP/01/01/05/2022 dated 27.01.2023 and Circular no. පීඑස්/සීඑස්ඒ/00/1/4/8 dated 15.03. 2023 issued by the Secretary to the President, such payment cannot be made using budgetary funds. Therefore, the airfare should be borne by the applicant.

Therefore, we would highly appreciate, if you could instruct the relevant officials to circulate this programme among the Institutions under your purview, and submit a suitable nomination in line with the TA Circular 2013/2014(ii), Circular dated 24.10.2013, of the Ministry of Finance, Planning and Economic Development Circular to this Department with the following documents;

- (i) Nomination letter (from the relevant ministry)
- (ii) Application Form (printouts of the online application form)
- (iii) ERD Form (can be downloaded from www.erd.gov.lk)
- (iv) A letter stating that the applicant will pay for the airfare, endorsed by the Secretary of the line Ministry, Head of the Department / Agency.
